#### **Minutes:**

It was moved by Jeff Gennuso and seconded by Tom Grieco to approve the Dec. 2009 meeting minutes. The motion passed.

**Correspondence:** All clubs need to obtain 501(c)3 status or use the group charter number. Only six clubs currently are registered 501(c)3. The address of record is the CJSL office. The benefit is cost & compliance. Turn a copy of the 990 postcard into the office. It costs the league a one time \$900 fee, it saves the club about \$850.

**Treasurer's Report:** (Attachment A) Financial statements handed out. Checks were handed out to clubs who were owed money.

**Bingo:** A report will be handed in next Tuesday with an end of year assessment. Board meetings are the 2<sup>nd</sup> Wednesday of the month.

- By-Laws/Constitution: (Attachment B) Brad Mahoney presented proposed changes to the bylaws for review. Proposed items were 2<sup>nd</sup> by Dan Neathery. These items will be voted on at the AGM.

#### **New Business:**

- League Direction/New Girls Program (Attachment C) Jim Reed was approached by several parents about the Odyssey girl's program. They were interested in breaking off from Odyssey (See Power Point Attachment D)

Slide 1 highlights- Reason for change from COSC- Lack of continuity from team to team, functions as a collection of teams that share a name.

Slide 2 Highlights-Goals- Set Curriculum, two age clusters, dual registration, uniform system of play, coaches stay in a set age group/ do not follow a team.

Slide 3- U10/13- two teams per age group, focus on individual player.

Slide 4- U14/18- two teams per age group, reinforce technical skills. Focus on tactical skills.

Slide 5- Elite Team- will be CYSA registered.

Slide 6- Fees- Club fees paid up front, coaching fees are monthly commitments, tournament fees collected within the team, monthly fees stay within the team.
