Minutes:

It was moved by Russ Pate and seconded by Gustavo Ansaldi to approve the October 2013 meeting minutes. The motion passed.

Treasurer's Report:

The deadline for reporting hardships was today. No hardships will be accepted after 7pm tonight. Hardships cost the league \$5-7k per year. We have several clubs with large outstanding balances. CJSL has paid all registration fees in full and needs to recover the funds.

It was moved by Anthony Toto and seconded by Craig Steitz to assess a \$1 per player fee to all clubs with outstanding balances on Dec. 5th. The motion passed.

Fields Report: With the time change comes added the need for lighted fields. Reminder- on lighted fields U8-U12 teams have priority from 5:30-7pm. U14 & up have priority from 7-9pm. DO NOT be on any of the high school fields before 5pm. Due to school activities.
