**Registrar's Report:** Andrea Lynott- Thanks for the on time back ups. The new software will be picked up tomorrow. Mandatory meetings will be held this month to load the new software. District 7 will be holding training sessions March 11<sup>th</sup> & 12<sup>th</sup>. Andrea has reserved a number of seats at each session. No registrations will be accepted from your club unless the new software is loaded. No players will be registered in clubs where data is incorrect.

**District 7 Report:** John Shelton- Item of emphasis is referee attire. A district site administrator may stop a game to send referees home if not properly attired. There are close to 30k players in the District. There is a TOPS Soccer program for developmentally disabled kids. If you know of a disabled player please contact the office & we will put you in contact with the program.

**Old Business:**

- Mike Campbell had questions about the incidents of coaches using non-rostered players. This is a club accountability issue. We may need to go back to using player passes next year.
- Referee Issues – Questions were addressed to Erick on the referee program. It is suggested that a form be put on the website for both positive & negative feedback on the referees.

**New Business:**

- Gold VP – Mike Hodges is recommending Jim Reed to fill the remainder of his 13 month term when he assumes the league Presidency. Jim has a daughter at Century & one with Odyssey. Duties to include District 7 rep. And Odyssey liaison to the E-board.

It was moved Mike Campbell and seconded Janet Reid-Bills to nominate Jim Reed as the Gold VP. The motion passed.

- Youth Rec Rules – A handout was provided for review of rules & procedures in the Youth Rec Program. This will be reviewed at the March meeting.
- Mentors- It is recommended that we look at providing new Commissioners with a mentor to help them through their first year.

**Good of the Game:**

- There is a signing party in the CJSL office tonight at 8:30 for several Odyssey players who will be signing their National Letter of Intent.
- Odyssey's U12 & U13 boys through the first round of State Cup.
- Nor-Cal Premier- 7 teams participated in the semi-finals, this was the highest total of any club in northern California. 96 teams participated in the semi-finals & finals at Clovis East.
