Club Bylaws- Any changes to Club Bylaws must be submitted to the office. Bylaws will be posted on the website. In case of any disputes the copy on file with the office will be the deciding factor in resolving the dispute.

Spring League- CJSJL has 87 teams participating, Dist. 7 has 220 teams. March 8<sup>th</sup> at 7pm in the Bingo Hall is a MANDATORY coaches meeting. There may be Sunday games due to the number of teams vs. the number of field locations.

Referee Courses: Preliminary dates; June 28-30, July 19-21, Aug 2-4. Courses are limited to 35 students. Registration for the classes require a \$55 non-refundable deposit.

Unit Realignment: Using registration numbers from the last two years we will work to make re-alignment recommendations at next months meeting.
