## **Minutes:**

**President's Report:** Changes are being made to tournaments and registration. More information soon.

**Treasurer's Report:** Only a few clubs still owe money. One club has turned in a 990-n, clubs who turn in a 990-n do not have to do a 501C3, they are covered by the league.

**Registrar's Report:** Old and new registrar's must turn in a 1622 and 1628. All info must be turned in by the end of the month. If any person answers yes to any question on a 1628 form, that paperwork must be sent to CYSA immediately.

**Fields:** Ken will be starting a list in May for clubs wanting to host games in the 2010 season.

**Bingo:** Rod will begin handling the books for Bingo. People working bingo are from Odyssey & Tops Soccer. Everyone is welcome.

**Fireworks:** Allen is checking on locations. Pre-sells start in May, will be handled the same as last year.

**Referees:** CJSJL has a second year referee being looked at for referee of the year.

#### **Old Business:**

Spring League: 102 teams participating. 42 teams from CJSJL. Season starts April 10<sup>th</sup>. Schedules are on the Spring League website.

Club Information: Clubs need to fill out the board change forms before the May meeting.

#### **New Business:**

VIP Cards- Mike Neil. Presentation on VIP Cards fundraiser. Cards sell for \$20, profit is 50% to team or individual. Unused cards can be returned.

Budget Summary: CJSJL charges \$55 per player. The light fund is being suspended as we have been collecting money and are waiting to see what CUSD is planning to do.

Coaches Courses: Schedules for coaches classes are being worked on and will be available as soon as confirmed. CJSJL does not control the date clinics are held. We must apply for a preferred date, and submit an alternate date. CYSA will select a date based on instructor availability.
