It was moved by Craig Steitz and seconded by Patrick Gilmore to approve the July 2015 meeting minutes. The motion passed.

**Treasurer's Report:** New this year for registration fees- if your account has a credit, checks for the amount of the credit will be written every two weeks so clubs have access to their funds more conveniently.

**Fields:** Odyssey has requested Dry Creek, Liberty and Riverview for practice & games. We will work with CUSD to resolve this, as Dry Creek and Liberty have lights installed that were paid for by the soccer club. All clubs need to keep their goals locked up, and work to build relationships with your principle.

**FC Clovis:** Has a tournament in September open to all U12-U19 teams. They currently have 17 teams registered for District play.
